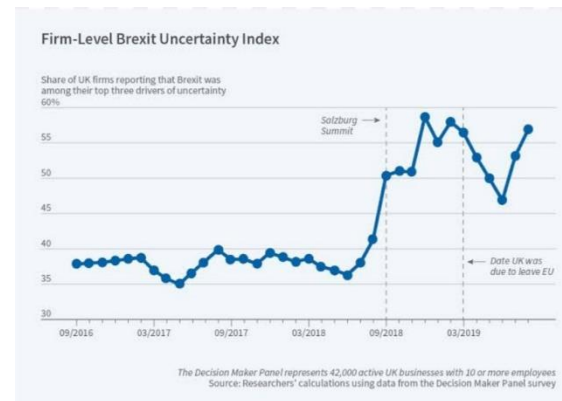

INTERNATIONAL BUSINESS

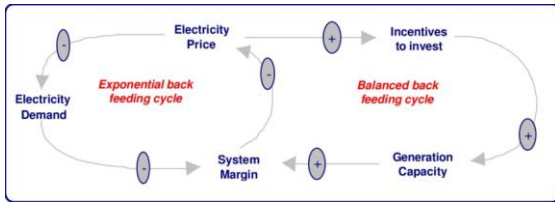
